How can I deposit money into my overseas 'migrant' bank account?

To make a payment into your overseas (migrant) bank account you will need to contact your local Westpac branch and request a foreign currency payment. You will need to provide them with the bank account details of your new 'migrant' account that the funds are to be credited. Alternatively, print the Overseas Transfer Form, complete it and send it to your local Westpac branch.

The payment of foreign currency out of the Fiji banking system is regulated by the Reserve Bank of Fiji. Please visit your local Westpac branch or [contact us](#) to discuss just how much you are able to remit overseas.
