Questions and Answers:

- Is my account still Open?

No, Your account is already closed. Funds are due to be transferred to Finance and Treasury Office,
- Can I open the same Account?

No, you will need to open a new account.
- How can I access my Funds?

You will need to come to your nearest Westpac Branch and ask to speak to a Customer Service Officer. You must bring along valid ID's or documents as evidence that you own the account.
- Will the Bank charge me a fee?

No - you will not be charged, nor be asked to pay a fee.
